## **DHCS Random PCP Site visits**

The CA Department of Health Care Services (DHCS), Medical Monitoring Unit, has advised The San Francisco Health Plan that they will be conducting onsite Facility Site Reviews and Medical Record Reviews of randomly selected Primary Care Provider sites during the week of February 23 – February 26, 2015. They will notify our Facility Site Review Nurse, Abby Wolf, when they have chosen which sites they will review. Abby will notify the chosen sites at that time and work with clinic staff to prepare for the DHCS reviews. ## **Pharmacy Update**

San Francisco Health Plan's formulary is available as a searchable and downloadable PDF file on our website! The drug formulary, formulary restrictions and step therapy tables can be found at http://www.sfhp.org/providers/formulary/sfhp-formulary.

Full formulary detail is also available through epocrates.com. Select the SFHP Medi-Cal formulary to see drug information, formulary status, and formulary alternatives within a drug class. Information on step therapy and drug criteria detail may also be viewed by clicking on "Formulary Status" hyperlink under the medication name.

Effective November 15, 2014 quantity limits will be applied on all types of topical tretinoin products. Tretinoin 0.01% and 0.025% gel will each have a quantity limit of 15 grams per

month and tretinoin 0.025%, 0.05% and 0.1% cream will each have a quantity limit of 20 grams per month. Members currently using higher quantities will be grandfathered until March 15, 2015 and will need to get a prescription for a formulary quantity limit after March 15, 2015 or have a prior authorization submitted by their provider explaining why higher quantity is needed.

Hydroxyprogesterone caproate (Makena®) will now be available effective January 13, 2015 in both the pharmacy and medical benefit. Hydroxyprogesterone caproate is used to reduce the risk of preterm birth in during pregnancies for women 16 years of age or older. For this drug to be covered as either a medical or pharmacy benefit, prior authorization criteria must be met. In the pharmacy benefit, it is restricted to SFHP's specialty pharmacy, US Bioservices. Please contact US Bioservices at **(888) 518-7246** for any questions or to transfer a prescription.

SFHP's specialty drug list is reviewed monthly and updated to reflect market changes. Please refer to the SFHP Specialty Drug List at http://www.sfhp.org/providers/formulary/specialty-pharmacy for any updates.

## **SBIRT Training Opportunities Available**

SBIRT is a comprehensive health promotion approach for delivering early intervention and treatment services to people with, or at risk of developing, alcohol use disorders.

The SBIRT benefit has three components:

- Universal Screening identifies people with potential alcohol use disorders.
- **Brief Intervention** is provided to a beneficiary when the universal screening indicates moderate risk for an alcohol use disorder.
- Brief Intervention utilizes motivational interviewing techniques focused on motivating people toward positive behavioral change.
- **Referral to Treatment** provides a referral to specialty care for persons deemed to be at high risk for an alcohol use disorder.

SFHP would like to share this strategic plan to our providers as a resource, and to help promote the importance of oral health.

From SF COH Strategic Plan: "Oral health is essential to overall health, well-being, and quality of life. It affects children's nutritional intake, self-esteem, and the ability to concentrate and succeed in school...In 2012, 35% of San Francisco Unified School District (SFUSD) students experienced dental caries in their primary and permanent teeth by the time they entered kindergarten, resulting in reduced attendance and contributing to poor academic performance. There can also be high costs; dental caries-related emergency

room visits can be ten times the cost of providing preventive care."
