## Non-Emergency Medical Transportation Reminder

Medi-Cal Members are entitled to use non-emergency medical transportation (NEMT) when physically or medically necessary, and the services are covered by Medi-Cal. NEMT is an ambulance, litter van, wheelchair van, or air transport that is provided when the Medi-Cal Beneficiary is unable to use a bus, taxi, or car to get to their appointments. NEMT must be authorized in advance and determined to be medically necessary. In order to establish medical necessity for NEMT, it is up to the referring physician to complete a Physician Certification Statement (PCS) Form, available online <a href="here.">here.</a>. Please complete every field of the form, as a complete PCS form is required to authorize the NEMT benefit, per the Department of Health Care Services (DHCS) All Plan Letter, APL 17-010. # **DHCS Delays Medi-Cal Rx Transition** until Further Notice

Department of Health Care Services (DHCS) is delaying the planned Go-Live date of April 1, 2021, for Medi-Cal Rx because of the need to review new conflict avoidance protocols submitted by Magellan

guidance and associated bulletins and articles in the coming weeks to reflect this timeline change.

## FSR Provider Pearl - National Colon Cancer Awareness Month: Medical Record Review Preventive Criteria for Colorectal Cancer



National Colon Cancer Awareness Month is an annual celebration observed in the United States during the month





of March, to increase awareness of colorectal cancer (CRC). The updated California Department of Health Care Services (DHCS) Medical Record Review (MRR) Standards (APL 20-006) and the DHCS Medical Record Review 2020 Tool include in the preventive services criteria, colorectal cancer screening

for adults aged 50 to 75 years. The decision to screen for colorectal cancer in adults aged 76 to 85 years should be an individual one, considering the patient's overall health and prior screening history. According to the Kaiser Permanente Research Affiliates Evidence-based Practice Center (EPC), survival largely depends on the stage of cancer at the time of diagnosis. Outcome is impacted by the time of diagnosis, e.g., localized disease or regionalized disease (cancer spread to regional lymph nodes).

The first chart demonstrates that the 5-year survival rates are highly dependent on the stage of advancement when the cancer is detected. But per the second chart, only 38% of cases are detected when the cancer is in the localized stage, while 22% of cases are already in the distant/metastasized stage when detected, where the 5 year survival rates are only 14%.

Currently, most U.S. guideline organizations, including the United States Preventive Services Task Force (USPSTF), agree that the recommended options in screening for CRC include colonoscopy every 10 years, annual high sensitivity guaiac fecal occult blood test (gFOBT) or fecal immunochemical test (FIT), and FecalSwab™ (FS) every 5 to 10 years with stool blood testing (FOBT or FIT). Among professional societies in the United States and internationally, primary care providers play an important role in providing important services to ensure appropriate screening and testing.

The FSR nurse will audit medical records to comply with the DHCS Adult Preventive Criteria, Colorectal Cancer Screening, to include: All adults beginning at age 50 years and concluding at age 75 years. Compliance may be achieved with evidence of the following: annual screening with high-sensitivity fecal occult blood testing; Sigmoidoscopy every 5 years with high sensitivity fecal occult blood testing every 3 years; or Screening colonoscopy every 10 years.





# **UM Update: Prior-Authorization Date Span Changes**

SFHP has implemented changes to the authorized date span of prior-authorization requests. The date span now ends 1 day sooner than previously calculated.

For example:

1) Year-long authorizations

a. Before: 2/11/21 to 2/11/22b. Now: 2/11/21 to 2/10/22

5. 140W. 2/11/21 to 2/1

2) 3-month authorizations

a. Before: 2/11/21 to 5/11/21b. Now: 2/11/21 to 5/10/21
