Topics Discussed

Quality Improvement

- Q1 2025 QI Scorecard presented by Yves Gibbons highlighted performance across 25 measures.
- Emphasis on improvement in ED follow-up and well-care visits for children in health equity populations.
- Discussion on methodology differences between hybrid and administrative measures.
- Planning for the transition to digital quality measures (dQMs) by 2030 has been initiated.
- Feedback provided on dashboard usability, data visualization, and data challenges (e.g., EMR fragmentation).

Health Equity Updates

- DEI Training Curriculum approved by DHCS; rollout planned for July/August 2025.
- Modules focus on trauma-informed care, health disparities, cultural humility, and equity in communication.
- Feedback is requested on naming, content, and CME options.
- Reciprocal training partnerships are being explored with other plans.
- TGI Training Curriculum is under development in collaboration with community partners.
- NCQA Health Equity Accreditation submission scheduled for June 23–24, 2025.

Utilization Management Updates

- UM Trilogy Documents presented and approved:
 - 2024 UM Evaluation
 - 2025 UM Program Description
 - 2025 UM Workplan
- Notable performance: 99% of authorization targets met; outpatient approval rates at 90%.
- Discussion focused on the use of MCG criteria, member safety, and the new Jiva system.

Other Updates

- Delegation Oversight Report presented by Crystal Garcia.
- 2024 marked major changes with new delegated functions and a centralized policy library.
- Quarterly workgroups launched for UM, claims, and compliance.
- Audit highlights included: Jade's low credentialing score, Hill's offshore data practices, and NEMS' 100% claims accuracy.
