1. Welcome. Steven Fugaro, MD, Chair, opened the meeting and welcomed everyone.

The motion passed unanimously.

Review and Approval of January 2025 Unaudited Financial Statements and Investment Reports. Anne Price, CFO, and Rand Takeuchi, Controller, presented the unaudited financial statements and investment income reports for the period ending January 31, 2025.

For the month of January, the margin was favorable to budget by \$4.7 million with a reported margin of \$7.2 million versus a budgeted margin of \$2.5 million. Drivers contributing to the favorable variance were favorable net investment income of \$2.2 million, favorable net administrative expense of \$0.9 million, and net medical expense of 1.6 million driven by an increase in 2025 capitation rates from Department of Health Care Services (DHCS). Excluding pass-throughs, the Medical Loss Ratio (MLR) came in favorable at 90.2% compared to budget of 91.3%.

There were no issues or concerns raised with the unaudited financials or investment reports.
