1. Welcome. Introductions and Roll Call:

3. Committee Reports:

Chair & Governing Board Report-Maria Luz Torre & Irene Conway Ms. Torre and Ms. Conway mentioned that the Board met on January 9, 2019. Nina Maruyama, Officer of Compliance and Regulatory Affairs will provide a Board report to Committee on John F. Grgurina, Jr., CEO behalf.

Lastly, Ms. Maruyama reported the Board approved the Quality Improvement Work Plan with no changes to drugs.
