Cost Avoidance & Post-Payment Recovery for Other Health Coverage (OHC)

Medi-Cal members must utilize their OHC for covered services prior to utilizing their Medi-Cal benefits per DHCS All-Plan Letter ([APL 21-002 \(ca.gov\)](#)). SFHP is required to make sure providers are identifying and billing the OHC carrier as primary coverage, prior to seeking payment from Medi-Cal. Managed Care Plans (MCPs) must include OHC information in their notification to the provider when a claim is denied due to the presence of OHC. MCPs and Medical Groups must ensure that Medi-Cal is the payer of last resort when the patient has OHC. Additional documents with information on the APL, Medical Group requirements, OHC reporting guidelines, and FAQs are posted on [APL 21-002 – San Francisco Health Plan \(sfhp.org\)](#).

Changes to the SFHP formulary and prior authorization criteria have been approved by the SFHP Pharmacy and Therapeutics (P&T) Committee at the P&T Committee meeting on July 21, 2021. The

Partnering to Promote myCAVax Enrollment and Administering the COVID-19 Vaccines (and all others)

A key strategy in this next phase of pandemic response is to engage PCPs as trusted resources for vaccinations. The vaccine is one of the most important ways to end the pandemic. Research shows they are highly effective and safe. For Medi-Cal members ages 0-21, depending on their eligibility status, the DHCS Managed Care Quality and Monitoring Division (MCQMD) requires providers to ensure that every member visit

provides the opportunity to update and complete each child's immunizations according to the Advisory Committee on Immunization Practices (ACIP), including the COVID-19 vaccination.

SFHP, in partnership with the San Francisco Department of Public Health (SFDPH) COVID Task Force, would like to share information for our providers with pediatric members. The goal is to encourage as many pediatric and family practitioners to be enrolled in the state's vaccine ordering platform [myCAVax](#), so that providers can offer vaccination to any pediatric patients ≥ 12 years old or their family members who have not been vaccinated.

The Pfizer Emergency Use Authorization (EUA) is anticipated to be extended to under 12 years old in the Fall (2-11 years of age). The SFDPH is extending their support to ensure that practices with pediatric members are set up now to administer the vaccine to this population once there is an amendment to the EUA. As you already know, many children and their caregivers will feel more comfortable being vaccinated by trusted provider than at an unfamiliar place. The DPH COVID Task Force is committed to providing guidance to every provider, beginning with the myCAVax enrollment process and will provide support for vaccination operations along the way.

Small providers should not have to incur costs in order to participate in the COVID-19 vaccination program. The [CalVaxGrant](#) can cover vaccination related costs of up to \$55,000 depending on the size of your practice. **The last day to apply for this grant is August 13, 2021.** To be eligible, practices must meet all the following criteria:

- Have a medical practice with no more than 200 physicians within the organization;
- Completed Section A and B of the [myCAVax](#) enrollment process;
- Spent or plan to spend \$10,000 per site (up to five sites) between November 1, 2020, and November 1, 2021, and;
- Have an unrestricted license and be in good standing with their licensing board.

We understand that there are additional concerns about offering COVID-19 vaccinations including questions about storage and handling requirements, order quantities, allocation sources, authorization requirements, or fear of vaccine mishandling
