COVID Vaccine Incentive Launch

SFHP is launching a **\$50 Visa gift card member incentive program** with financial support from DHCS. Letters are being sent to unvaccinated Medi-Cal members announcing that they are eligible for the incentive. Members who complete their vaccination (both shots or one shot, depending on protocol) between 9/1/2021 and 2/28/2022 will be mailed the gift card automatically. Please encourage members to keep SFHP informed of their most up to date mailing address (SFHP Customer Service 1(415) 547-7800). Members who were fully vaccinated prior to September 1, 2021 are automatically entered into a weekly raffle for a \$50 gift card. FSR Provider Pearl: Diabetes Screening



November is National Diabetes Month, More than 1 in 3 U.S. adults have prediabetes and the majority of people are not aware that they have it (NIDDK, 2021). Diabetes screening and comprehensive diabetic care are assessed in the Medical Record Review (MRR) as part of the Facility Site Review (FSR) process. From a sample of records reviewed 2019 to

present, 75% of eligible adult charts included documentation of diabetes screening, and 81% of eligible adult charts included

documentation of comprehensive diabetic care.

The following chart includes details regarding diabetic screening, comprehensive diabetic care criteria, documentation standards, and provider resources. Please note that the United States Preventive Task Force (USPSTF) updated the

Comprehensive Gender-Affirming & Primary Care for Queer, Trans and Non-Binary Youth, ages 12-25, at Dimensions Clinic

Dimensions Clinic for Queer and Trans Youth is a primary care clinic that functions out of Castro-Mission Health Center on Thursday evenings (from 5pm-8pm) and Saturday afternoons (from 12pm-3pm), and provides comprehensive, interdisciplinary care tailored toward TGNB and queer identifying young people. Founded in 1998, Dimensions has historically worked with multiple queer focused partner agencies and aims to provide a welcoming and supportive environment for QTGNB youth – connecting them to community and social services. Dimensions provides a full range of services including:

- · gender-affirming care, including hormone therapy, puberty blockers and surgery referral
- wellness check-ups & standard primary care
- · reproductive and sexual healthcare
- · HIV screening and prevention
- in-person and remote behavioral health counseling
- psychiatry
- support with navigation of gender-affirming surgeries
- · support with navigation of insurance issues.

Temporarily located on the ZSFG campus in Castro-Mission's relocated site (while the clinic is under renovation),
Dimensions is located at 995 Potrero Ave (Building 80), in Ward 81 South (1st Floor). Dimensions offers its full scope of services to SFHP patients and Dimensions providers are available as a consultation and referral resource for any other programs that serve SFHP patients.

Pharmacy Updates: Quarterly Formulary and PA Criteria Changes, Voluntary Recall of Varenicline (Chantix) Due to Nitrosamine

Pharmacy Update Quarterly Formulary and Prior Authorization (PA) Criteria Changes

Changes to the SFHP formulary and prior authorization criteria have been approved by the SFHP Pharmacy and Therapeutics (P&T) Committee at the P&T Committee meeting on October 20, 2021.

UPDATED: Drug Safety Communication: Voluntary Recall of Varenicline (Chantix) Due to Nitrosamine

On September 17, 2021, the U.S. Food and Drug Administration (FDA) announced a voluntary manufacturer recall of all lots of varenicline (Chantix) 0.5 mg and 1 mg tablets due to levels of a nitrosamine impurity above the FDA's acceptable intake limit. N-nitroso-varenicline may be associated with a potential increased cancer risk in humans associated with long-term use, but there is no immediate risk to patients taking this medication. The FDA recommends that patients taking recalled varenicline should continue with their current medication regimen as prescribed, until either their pharmacist provides a replacement, or their doctor prescribes a different medication. The health benefits of stopping smoking outweigh the cancer risk from the nitrosamine impurity in varenicline. More information is available on the DHCS Drug Safety Communication bulletin.
